Covid-19 Lodge Rental Agreement

This plan is to protect the health and well-being of our customers.

It is intended to ensure that each group that rents the facilities at Oakland Farm & Lodge understands and agrees to comply with the most recent provincial Mandatory Order (Currently dated August 6, 2020)

- 1. Physical Distancing:** This practice has been shown to be one of the most effective ways to control the spread of Covid-19. As the owners, we are required by law to take all reasonable steps to ensure people not inside a bubble **keep 2 meters (six feet) apart from each other** and to prevent gatherings exceeding the prescribed limits.
Maximum number of people outside has been lifted
Maximum 50 people inside

Please explain how you will ensure that your group will maintain at least 2 meters (6 feet) between people who are not in a bubble. Please also explain how you will ensure that maximum number of people allowed is not exceeded.

- 2. Non-medical masks:** Where physical distancing cannot be maintained, **masks that cover the mouth and nose are mandatory** as an additional measure to prevent the transmission of Covid-19. This is especially important inside buildings.

Please explain how you will ensure that your group will wear masks when physical distancing cannot be maintained.

3. Screening: As the owners, we are required by law to take all reasonable steps to **prevent persons who are exhibiting symptoms of Covid-19 from entering the premises.** As the owners, we are also required by law to take all reasonable steps to **prevent persons who have travelled outside of the Atlantic bubble in the last 14 days from entering the premises.**

Please explain how you will ensure that no one in your group exhibits symptoms of Covid-19 or has travelled outside of the Atlantic bubble in the last 14 days.

4. Contact Information: The Mandatory Order requires that any venue that offers seating “for the purposes of eating, drinking, socialization, celebration, ceremony or entertainment” **is required to maintain a record of the names and contact information of all persons who attend.**

We will provide a template that records all attendee’s names and telephone numbers and/or email addresses. **A copy must be provided to the lodge owner.**

5. Hand washing and Sanitizing: Frequent thorough hand washing and hand sanitizing are effective ways to prevent the spread of the Covid-19 virus.

Please ensure that you have stressed the importance of this to your guests. There are sinks in both washrooms and the kitchen as well as two hand sanitizer stations inside the lodge.
